#### **TENDER CALL NOTICE**

Sealed quotations / tenders are hereby invited from all interested persons / Registered Firms/ Travelling Agencies/ Trust having only commercial light vehicles (INNOVA/SCORPIO/ERTIGA) for contractual deployment under CENTRAL SANSKRIT UNIVERSITY, SH. RAGHUNATH KIRTI CAMPUS, DEVPRAYAG, DISTT.- PAURI GARHWAL, UTTARAKHAND – 249301 for official use on monthly rent basis which shall conform to the following terms & conditions.

- 1. The vehicle must be in road worthy condition, shall not be more than Six Month old from the date of initial registration & must have valid Registration Certificate, Insurance Certificate, proof of up-to-date tax payment etc. which are mandatory for six months old vehicles or applied for new latest vehicle may also eligible.
- 2. The monthly rate hire charges must be quoted separately in the general bid information (Excluding Fuel). The details of Make, Year of mfg. of vehicle, Registration No., mileage (kms covered per ltr), and Name of the driver with driving license No. & period of validity should be specially provided in the general bid information format.
- 3. The driver who will be engaged to drive the vehicle by the agency/driver of the University must have a valid driving license for driving light vehicles and should be sufficiently experienced in driving the vehicle. The driver must follow the traffic rules and other regulations prescribed by the Government of India to this effect from time to time. The University has the right to ask the agency for removal of driver in case found incompetent, disorderedly or undisciplined.
- 4. The driver should be well behaved, gentle and obedient in nature. The driver must observe all the etiquette and protocol while performing the duty. He must be neatly dressed and carry a mobile phone for which no additional payment shall be made by the University.
- 5. <u>Fuel:</u>The fuel consumed during the period of running may be supplied by the University.
- 6. <u>Drivers liability</u>: The salary and other benefit to driver of vehicle will be borne by agency.
- 7. Repair & Maintenance: Repair and maintenance will be at the cost & risky of Agency.

- 8. <u>Substitute</u>: The agency has to provide a similar type of vehicle only as an alternative arrangement during the break down of the above vehicle. Road tax, will be borne by agency.
- 8. <u>Documents</u>: All valid documents of vehicle such as driving license of the driver, road tax, ownership, R.C.Book, fitness, insurance etc. should be up-to-date and available with the driver at his custody.
- 9. <u>Log Book</u>: The driver has to maintain a log book. All the entries will be made on daily basis and the log book will be countersigned by the Officer used the vehicle. The log book will be submitted by the driver once in a week before the Campus office/Caretaker for verification of same.
- 10. <u>Payment:</u> The payment towards hiring of vehicles shall be made on monthly basis. The agency is required to submit the bills in DUPLICATE along with the supporting documents within 7<sup>th</sup> of every month in the Office of CENTRAL SANSKRIT UNIVERSITY, SH. RAGHUNATH KIRTI CAMPUS, DEVPRAYAG to process the bill for payment. No advance payment will be made in this regard.
- 11. Tax: GST will be paid extra as applicable if any.
- 12. The toll fee/entry fee/parking fee etc. will be reimbursed along with the monthly bill subject to production of slips/tickets.
- 13. The vehicle should conform to the pollution norms prescribed if any by the Transport Department of Government.
- 14. The vehicle must be kept neat and clean and in perfect condition and should be provided with the basic neat and clean seat covers and curtains.
- 15. The agency shall provide vehicles as per the requirement of the University as and when required.
- 16. The rate contract for hiring of vehicles shall be valid initially for one year and can be curtailed / extended by the University. Either party can terminate the contract within 30 days prior notice.
- 17. In no case the rate will be revised during the period of contract with the revision of cost of fuel, labour etc. if any.
- 18. The University will not be responsible for any legal disputes with any party in connection with the vehicle/owner or any other accident during the period of engagement.
- 19. The University shall not be held responsible whether financially or otherwise for any injury or loss to the driver or person deployed by the agency during the course of performing duties. On the other hand, the agency will remain liable for and indemnify the University against any injury, loss/damage caused to the user officers/employees due to negligence of the driver or any other person deployed by the agency while executing the work.

- 20. The penalties as would be decided by the University shall be imposed on the agency for not providing vehicles in time, misbehavior of driver or for not providing substitute vehicles when required.
- 21 A sum of Rs. 5000.00 shall be deposited by intending bidders in shape of A/C payee bank draft drawn in favour of the Director, Central Sanskrit University, Devprayag and submitted along with the quotation as security deposit. After completion of process, the amount will be refunded to unsuccessful bidders.
